9. Proposals for Changes to Current Rules & or Constitution

Amendment to Rule 3.7 change proposal by Middleton.

REASON

Whilst our Club would not support the proposal as presented due to the playing time stated there is some merit in what Middleton are proposing.

I believe the current Rule 3.7 should be amended to insert after 'one of which must be at the weekend' 'and one on a weekday' with no mention of playing times.

At present it is allowable to offer all three dates at weekends which, as in Middleton case, can be restrictive with availability.

Under current rules the start time can be negotiated between the Clubs.

CHANGES TO PROPOSED WORDING

Clubs must offer three dates during the period allocated for the round at least one of which must be a weekend, and at least one of which must be a weekday. Any dates offered shall not include dates on which the opponent already has a league match agreed.
